Forestry Stewardship Council® (FSC®) What is FSC®?



FSC® is an independent, non-governmental, not-for-profit organisation established to promote the responsible management of the world's forests. It is the only globally valid standard. FSC® finds solutions to the problems created by bad forestry practices and rewards good forestry management.

Purchasing FSC® certified products ensures the paper comes from responsibly managed sources. Forests managed by FSC® standards are sustainable forests and offer benefits to local and wider communities; contributing to lessen the effects of climate change.

What is Chain of Custody (COC)?

COC certification is the way of tracking wood material from certified forests, responsible sources and reclaimed material at any point along the supply chain.

All companies throughout the supply chain must have certification to ensure that the paper product is certified.

Being FSC® COC certified allows us to promote responsible forest management, and pass on the qualifications of FSC® certified product (paper) from our supplier to our clients. We have stringent requirements to meet in order to maintain our certification.

When you choose to use FSC® certified paper for your labels you are supporting a much larger cause.

Not only does it indicate that the pulp used to make the label paper comes from sustainable forests, but it also shows support for the wider community, because the Forestry Stewardship Council® addresses issues such as poverty reduction and social and political empowerment of the forest workers and owners.

The flow on effect of using FSC® certified paper for your labels is supporting employment, housing and economic well-being in local communities where the sustainable forests are, and FSC® ensure there is no child labour or exploitation of the indigenous people in those areas. FSC® accredited certification bodies audit and certify all individual forest management operations to ensure they follow the requirements set out by FSC® and are fully compliant with them.

How you **communicate your support on your label** is by choosing to include an on-product claim, by using Rapid Labels' FSC® logo with our specific trademark licence code on the FSC® Certified label paper.

This FSC® logo is included on your label prior to printing. The following page outlines how to go about adding one onto your label and the FSC® logo brand guidelines that need to be followed.

This page outlines the steps to go through when you choose to include an on-product claim, by using Rapid Labels' FSC® logo and specific trademark licence code.



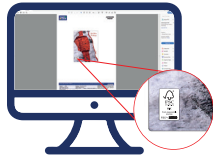
Order your labels and request FSC® certified paper for your labels



Supply your new artwork with a place-holder to indicate where the FSC® logo should go or we'll add it onto existing artwork

There are Brand Guidelines that will need to be followed when thinking of where to place the FSC® logo, colours, size and format.

Once you choose to include an on-product claim, we'll send you more information about this process.



Our Prepress team sends you a proof with the FSC® logo added to your label artwork



Once we receive approval for the FSC® logo use, we proceed with printing and delivering your labels



Once we receive your approval, we send the artwork away for final placement approval

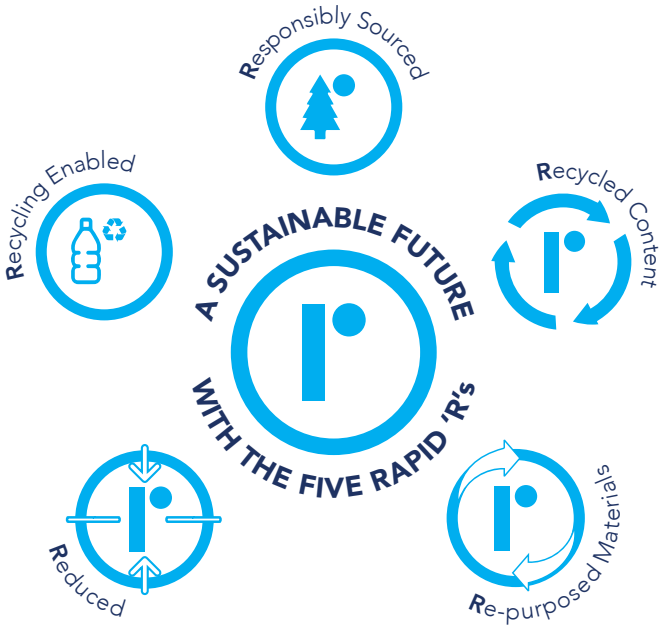

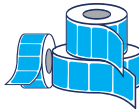

Rapid sends an invoice with confirmed freight and handling fees before sending a replacement box and pallet
